

Offshore operations and Environmental Impact Assessment: Lessons Learned from Seismic IEEs, and Next Steps

CONCEPT NOTE & AGENDA

In August 2014, MCRB hosted a government-business dialogue on environmental and social impacts of shooting seismic offshore¹ which brought together 10 operators, and government department including MOECF, MOGE, DICA, Fisheries and regional government (GAD). Subsequently MCRB facilitated the provision of follow up comments² by a number of oil and gas companies on the draft Environmental Impact Assessment (EIA) Procedures with the intention of supporting the Government of Myanmar in bringing the Procedures into line with international standards. These issues, and the interface with Myanmar Investment Commission procedures have also been raised in the Natural Resources Working Group of the Myanmar Business Forum³. Many operators have since then undertaken Initial Environmental Examinations or EIAs and submitted them to government.⁴

Adoption of the [EIA Procedures](#) on 29 December 2015 (MOECF Notification 616) has brought greater clarity to some of the issues raised in the August 2014 workshop, and many operators have since undertaken and submitted IEEs and EIAs. However some issues remain unclear. MCRB proposes a follow-up one day multistakeholder workshop with the following objectives:

- To raise awareness of the stages of the offshore exploration and development process amongst non-business stakeholders
- Share experiences and lessons from offshore IEE/EIAs conducted in 2014/2015, and gather lessons learned [especially in terms of interaction with stakeholders, time framework, dead-lines, coordination]
- Facilitate intra-government coordination (MOE/MOGE, MOECF (now MONREC), MIC, Regional ECDs) and clarify roles and next steps according to procedures (audits, ECCs).
- Identify possible solutions to remaining issues including the process for feedback following submission to government; issuance of Environmental Compliance Certificates;
- Discuss EIA requirements for future drilling operations;
- Discuss pragmatic solutions for approving Environmental Management Plans and granting Environment Compliance Certificates to existing offshore installations.

The discussion will be in English on a Chatham House Rule basis. A report of the event will be published on MCRB's website, as with the previous meeting.
